Follow the signs for 222 North/Allentown. Exit at Broadcasting Road. Make a right at the traffic signal onto Broadcasting Road. Make the first right onto Harper Road (campus entrance).

#### From Harrisburg, PA and Points West

Take the Pennsylvania Turnpike East to Exit 286 (Reading/Denver). Exit to 222 North. Follow the signs for 222 North/Allentown. Exit at Broadcasting Road. Make a right at the traffic signal onto Broadcasting Road. Make the first right onto Harper Road (campus entrance).

# From New York City, Northern New Jersey, New York and New England

Take the New Jersey Turnpike south to Exit 14 and I-78 West. Continue on I-78 West into Pennsylvania to 100 South (Fogelsville Exit). Continue on Rt. 100 South to 222 South.
